**EMPLOYEE AGREEMENT**

Rehearsals are flexible but Actor/Employee is expected to show up and rehearse as predetermined and stated and attached as an APPENDIX to this agreement.

2. Actor/Employee acknowledges and understands that ( ) and all rehearsal spaces are being leased by the Producer and that A/E shall conduct himself at all times in a cordial orderly manner so as not to disrupt, destroy or otherwise cause damage to said leased property.

3. A/E agrees to no liquor or any illegal substance on leased property.

4. A/E agrees to comply with any and all applicable laws, ordinances and requirements by any public authority and indemnify, defend and hold Producer harmless for any and all violations of same.

5. Actor/Employee shall not give, copy or relay any material, script or video/audiotape information (provided by Producers) for the project . . . ( ) to anyone for any reason without first receiving permission from Producer.

6. Actor/Employee acknowledges and understands in signing this agreement that he/She is held to his/Her duties of this agreement for the duration of the project. In the event of a conflict, A/E must notify Producer no later that three weeks, (21 days) prior to ( ).

7. In the event of any breach of any of the terms or provisions of this agreement by Actor/Employee, He/She can be held liable for any portion up to and including the entire cost of this project.

8. There are no representation, promises, warranties, covenants or under-takings other than those contained herein. This agreement represents the entire understanding of the parties, and cannot be amended or modified except by a written document signed by both parties. This agreement supersedes any prior agreement.

9. This agreement shall be interpreted, construed and enforced in accordance with the laws of the State of California applicable to agreements entered into and to be wholly performed therein.

10. Timely and prompt performance of the parties' respective obligations hereunder are of the essence of this agreement.

11. Failure to insist upon compliance with any of the terms covenants or conditions hereof shall not be deemed a waiver of such terms, covenant or conditions.

12. If any action or proceeding is brought by Producer to terminate or enforce any provision of this agreement or to obtain damages, the prevailing party shall be entitled to reasonable costs and expenses in such action or proceeding, including attorneys' fees.

13. **AMERICANS UNITED FOR AMERICA INC.**, Charles Emmett and any additional employees of said company and producers are unaware and do not condone any illegal activity by you and reserve the right to terminate your employment when suspicious, informed, and or notified by law enforcement. Said company also reserves the right to withhold all employment fees owed to A/E pending the disposition of said illegal activity so as not to appear to be funding any illegal activity by you.
